## Elkton City Council Minutes December 3, 2018

The Elkton City Council meeting was called to order by Mayor David Landsman at 7:00 PM. Council members present were Deanna Lundgren, John Miraglia, Stewart Salzman, Nancy Spiering, Nieema Thasing, and Christina Wiemer. Also in attendance was Dave McMahon, Bill Fargen, Victor Cajiao, Greg Nelson, Jeff McCormick with SPN and Greg Maag with First District.

Motion by Spiering, second by Wiemer to approve the agenda as presented. All in favor – motion carried.

Motion by Lundgren, second by Thasing to approve the November 5, 2018 regular meeting minutes. All in favor – motion carried.

Motion by Spiering, second by Salzman to approve the November 14, 2018 special meeting minutes. All in favor – motion carried.

The council held a hearing for the proposed water and wastewater infrastructure improvements. Jeff McCormick, city engineer took the floor to discuss and answer any questions about the infrastructure replacement project. A water study was conducted and showed 45% of the current water lines are old cast iron in town. The proposed phase #1 project has a total cost of \$5.6 million. Bonds for these projects will be paid back by revenue collected on utility accounts over a 30 year period. Resolution 2018-12.01 was read to approve the submission of the City's application to the DENR for the proposed sewer project. Greg Maag with First District Association of Local Governments reviewed the Brookings County Pre-Disaster Mitigation plan with the council. The council made a few changes to the plan.

During citizen comments Greg Nelson asked if there was an ally behind his property at 903 Elk Street. Nelson also discussed street light placement for additional street lights. The council approved placement of one on North Drive. There was discussion of adding another light on South Elk Street.

A list of building permits issued during 2018 was available for council to review.

Public Works Director, Steve Jensen was on hand to give his report. All but three of the trees in the tree bank have been replanted. A culvert has been dug out on the west side of Cornell Ave to help drain the water from Tim Anderson's pumps. A lift station pump burned out from being jammed with flushable wipes over the weekend. Replacement cost is just under \$3000.00. Liberty septic has been called to vacuum out the sewer system. Stop signs will be placed at Buffalo and 4<sup>th</sup> Street on the north and south side of streets.

Denise Aldrich, Bar Manager was not in attendance and there was no report.

Finance Officer, Susan Schuurman was on hand and gave her report. Almost caught up on financials in the office. Schuurman will call the auditor to schedule a 2 year audit for 2017

and 2018. Discussion about water and sewer rate increases. Schuurman will continue the 3% water rate increase as allowed by resolution in January. Schuurman proposes a \$0.75 increase to \$4.00 per 1000 gallon usage for sewer rates to become effective January 15, 2019.

There were no reports for the Ambulance or Fire Department.

Sherry Bauman, City Librarian was on hand with her report. Story hour continues to go well. The Elkton Hero Days Committee book give away will be held at the Community Library on Tuesday December 18<sup>th</sup> from 5-7 PM and Thursday December 20<sup>th</sup> from 5-7 PM. The library has a tree a display at the Festival of Trees. The 1000 Books Before Kindergarten reading program now has 18 children registered and one has already reached the half-way mark of 500 books. The daycare deliveries are going well. Bauman has begun working on the summer reading program for 2019. The theme is "A Universe of Stories" and focuses on space. Holiday hours will be: closed Mon. Dec 24 and Tues. Dec 25, Mon Dec. 31 and Tues. Jan 1. The next library board meeting will be Wednesday, January 16<sup>th</sup> at 5 PM.

The council reviewed the budget overviews for August, September and October.

The council read Resolution 2018-12.03 to transfer funds to cover budget shortfalls. Motion by Wiemer, second by Thasing to approve the resolution. All in favor – motion carried.

The council held the second reading of the 2018 Budget Supplement Ordinance No. 364. Motion by Miraglia, second by Spiering to pass Ordinance No. 364. All in favor – motion carried.

In old business, motion by Spiering, second by Thasing to pay the increase of group insurance for the 3 full time employees. All in favor – motion carried.
