## Elkton City Council Minutes January 4, 2018

The Elkton City Council meeting was called to order by Mayor David Landsman at 6:40 PM. Council members present were Tal Farnham, Carol Jensen, Deanna Lundgren, Robin Mulvey, Stewart Salzman and Nancy Spiering. Also present was Norma Lynn representing the Elkton Record.

Motion by Spiering, second by Lundgren to approve the agenda as printed. All in favor – motion carried.

Motion by Salzman, second by Spiering to approve the December 4 regular meeting minutes. All in favor – motion carried.

Motion by Lundgren, second by Spiering to approve the December 19 special meeting minutes. All in favor – motion carried.

Motion by Salzman, second by Jensen to approve a Temporary Liquor Permit for Jan 13<sup>th</sup> Holiday Party. All in favor – motion carried.

Motion by Spiering, second by Lundgren to approve a Temporary Liquor Permit for Jan 18th for the Community Club Banquet. All in favor – motion carried.

Steve Jensen, Public Works Director was on hand and gave his report. No lift station problems this month. There have been a few broken or frozen water meters that have been replaced. Snow piles have been hauled out of town. Jensen and Lynn made a sand spreader to make spreading sand easier and better. Jensen will attend a stabilization pond class on Jan 30th in Mitchell.

Bar Manager, Denise Aldrich was on hand and gave her report. Aldrich reported a good month despite video lottery commission down. The off sale area, including the shelves were recently painted. Plans are to work on the rest of the bar after Super Bowl. The bar will host a Super Bowl party. There will be entertainment from Outlaw Entertainment on February 10<sup>th</sup>. Aldrich plans to purchase a new 55" TV for the SW corner of the building before Super Bowl.

Susan Schuurman, Finance Officer gave her report. There have been some issues with the furnace in the community center. Gene from CHS has been over. The city will have him check all the furnaces every year for \$150.00 per year. An apartment complex owned by Sunrise Development had a large water leak this past month. Schuurman's proposal was to charge the owner the average usage and then the remainder at cost to the city. They would be charged the average sewer, because the water went into the ground due to a dirt floor. Motion by Spiering, second by Mulvey to approve the adjusted bill. All in favor – motion carried. City Elections will be held on April 10th, 2018, seats up for this year include: 2 year terms for Dave Landsman, Mayor; Carol Jensen, Ward 1, Robin Mulvey, Ward 2, Tal Farnhma, Ward 3 and a 1 year term for Deanna Lundgren, Ward 2. Petitions can be taken out starting on January 26th and must be turned in by 5 PM on February 23rd. Work in the office includes end of the year paperwork and annual report.

The Fire Department will hold elections tonight at their meeting.

The Ambulance is planning a breakfast to raise money for the new cot. A refresher course is planned for March 16-18th.

City Librarian, Sherry Bauman was not in attendance but left her report. Story Hour will resume on January 8th. Due to daycare situation, attendance has gone from 10 to 4-5. The school/community library had a tree on display in the Festival of Trees. Sherry was notified that it won first place. The tree was a candy themed tree with a sign that read "Reading is a Sweet Treat." The next library board meeting will be January 10th at 5:00 PM.

Park and Rec news, the city will advertise for a new director and put out for bids on the concession stands for the summer.

The council reviewed the budget overview for December.

The council reviewed the Salary resolution 2018-01.01. Motion by Jensen, second by Lundgren to approve the resolution. All in favor – motion carried.
