Elkton City Council Minutes June 4, 2018

The Elkton City Council meeting was called to order by Mayor David Landsman at 7:09 PM. Council members present were Deanna Lundgren, John Miraglia, Stewart Salzman, Nancy Spiering, Nieema Thasing, and Christina Wiemer. Also in attendance were Gordon and Mary Lee, Sheryl Vaske, Greg Nelson, Victor Cajiao, and Cary Wadsworth.

Motion by Lundgren, second by Spiering to approve the agenda as presented. All in favor – motion carried.

Motion by Salzman, second by Lundgren to approve the May 7, 2018 regular meeting minutes. All in favor – motion carried.

Motion by Spiering, second by Thasing to approve the May 22, 2018 special meeting minutes. All in favor – motion carried.

During citizen comments: Greg Nelson of Ottertail power questioned the council of placement of new street lights at the intersection of Elk and 9th Street, and at the south end of Elk Street.

Three building permits were issued in the past month. Building Permit #471 to Nathan Pester to pour a 15'x24' concrete patio and a 10'x30' concrete driveway on his property at 600 Antelope Street. Building Permit #472 to Sam Wiskur to replace existing concrete pad with at 12'x12' pad on his property at 103 Cornell Ave. Building permit #473 to Matthew Houselog to cover deck, add a window and pour a 25' circular concrete pad for a grain bin gazzeebo on his property at 403 W 3rd Street.

Variance Permit #042 for Gordon and Mary Lee was discussed. Motion by Salzman, second by Lundgren to approve Variance Permit #042. All in favor – motion carried.

Public Works Director, Steve Jensen was not in attendance but left a report. The annual lift station inspections are complete with no problems found. The lagoon discharge is complete. Blocks and materials for the tree bank memorial have been purchased. The park shelter was pressure washed; two speed bumps have been installed by the park on 5th and 3rd Street. Alley work has been started, they have been scraped and gravel has been placed in some alleys. The light pole at the corner of Elk and 1st Street in front of Elkton Electric has been reinstalled. The new Welcome to Elkton banners have been hung. Some bushes have been replaced out at the lagoon. Water pressure problems have been reported around town, Brookings Duel Rural Water has had high demand, as has the City creating the problem. CHS has been asked to draw their water from the well at the corner of Badger and 4th Street.

Denise Aldrich, Bar Manager was not on hand and there was no report for the bar.

Finance Officer, Susan Schuurman was on hand and gave her report. She reminded the council that she would be out of the office June 5-8th for training. Schuurman requested the change of the July regular meeting. Motion by Spiering, second by Thasing to change the date to July 5th at 7:00 PM. All in favor – motion carried. Schuurman advised the council of the Elected Officials workshop on July 18th in Pierre. Carol Jensen will start training in the office on June 11th for when Schuurman takes maternity leave in July. The Miss Elkton pageant will be held in the community center on June 11th. Cary Wadsworth was on hand and asked for the rental fee to

be waived for a benefit being held for Skylar Jones on June 24th. The benefit will raise funds to send Ms. Jones to a national Miss Amazing pageant, representing South Dakota. Motion by Wiemer, second by Thasing to waive the fee. All in favor – motion carried.

The Fire Department and Ambulance did not have anything to report to the council.

Sherry Bauman, City Librarian was on hand to give her report. The Summer Reading Program will kick off on June 12 and 13. The Hagen family will be on hand June 12th to demonstrate various musical instruments. The library will host a book discussion on Thursday, July 19th at 7:00 PM for "The Master Butchers Singing Club" by Louise Erdrich. The library board is seeking two Elkton residents to serve as library trustees, representing the community of Elkton, each would serve a three year term.

Park & Rec Director, Mary Lynn was on hand with her report. There are 57 kids signed up for summer rec activities. Lynn requested the city purchase a projector for movie nights and the unit can be rented out for events at the community center. Motion by Wiemer, second by Salzman to purchase a projector unit. All in favor – motion carried.

The council reviewed the budget overview for May.

Committee reports: Councilmember Wiemer spoke with Sheriff Stanwick about issues. Stanwick recommended the city consider more coverage hours. Calls coming in from non English speaking residents are taking up a lot of hours in the month. Wiemer also talked to the bar manager about upgrades she is interested in doing to the bar.
